Subject: - Grant of Dearness Allowances - Revised rates effective from 01-01-2017.

In pursuance to the Govt. of India, Ministry of Finance, Department of Expenditure OM No.1/3/2017-E-II(B)(8) dated 30/3/2017(copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Allowance payable to State Government Employees shall be enhanced from the existing rate of 2% to 4% of the basic pay with effect from 1st January, 2017.

2. The Dearness Allowance payable under this order shall be paid in the following manner:-

- (i) The arrears pertaining to financial year 2016-17 shall be credited to GPF accounts of employees,
- (ii) The amount payable for current financial year shall be paid in cash to be credited to respective salary accounts,
- (iii) For NPS account holders, the arrears as well, will be paid in cash to be credited to their salary accounts.

3. The expenditure on account of this Dearness Allowance will be met from existing Budget provisions of the Department concerned in the Current Financial year 2017-18.

4. The revised rates of Dearness Allowance will be applicable to regular State Government employees only and will not apply to private /Non-Governmental institutions receiving grants-in-aids from the State Government.





In pursuance to the Govt. of India, Ministry of Finance, Department of Expenditure' OM No.1/1/2018-E-II(B) dated 15/03/2018 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Allowance(DA) payable to State Government Employees shall be enhanced from the existing rate of 5% to 7% of the basic pay with effect from 1st January 2018.

2. The DA arrears w.e.f 1/1/2018 shall be credited in the bank accounts of all Govt. employees in the revised pay structure of 7th Pay Commission.
3. The expenditure on account of this Dearness Allowance will be met from existing Budget provisions of the Department concerned in the Current Financial year 2018-19.
4. The revised rates of Dearness Allowance will be applicable to regular State Government employees only and will not apply to private /Non- Governmental institutions receiving grants-in-aids from the State Government.



Subject: Grant of Dearness Allowance to Central Government employees - Revised Rates effective from 1.1.2018.

The undersigned is directed to refer to this Ministry's Office Memorandum No. 1/9/2017-E-II (B) dated 20th September, 2017 on the subject mentioned above and to say that the President is pleased to decide that the Dearness Allowance payable to Central Government employees shall be enhanced from the existing rate of 5% to 7% of the basic pay with effect from 1st January, 2018.

2. The term 'basic pay' in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix as per 7th CPC recommendations accepted by the Government, but does not include any other type of pay like special pay, etc.
3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).
4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
5. The payment of arrears of Dearness Allowance shall not be made before the date of disbursement of salary of March, 2018.
6. These orders shall also apply to the civilian employees paid from the Defence Services Estimates and the expenditure will be chargeable to the relevant head of the Defence Services Estimates. In respect of Armed Forces personnel and Railway employees, separate orders will be issued by the Ministry of Defence and Ministry of Railways, respectively.
7. In so far as the employees working in the Indian Audit and Accounts Department are concerned, these orders are issued with the concurrence of the Comptroller and Auditor General of India.


